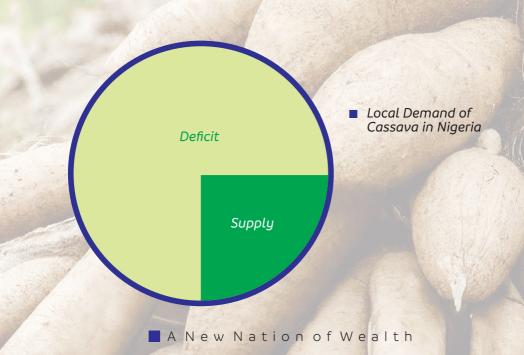






The Economics

o meet the demand for cassava by-products and derivatives in Nigeria, the country needs to plant around 28.3 million metric tons of fresh cassava root annually on about 1.2 million hectares of land. Nigeria is a leading producer of cassava, but there is a gap between supply and demand for cassava products: Cassava starch: There is an estimated annual demand of 310,000 tonnes of cassava starch, but only around 20,000 tonnes are available. Cassava flour: There is a supply-demand gap of about 485,000 metric tons of high-quality cassava flour. Ethanol: Nigeria imports about 97 percent of the ethanol it uses locally According to a Nigerian Presidential Initiative of July 2002, the cropped area of cultivation of cassava was proposed to be increased to 5 million hectares by the end of 2010 with a projected annual yield of 150 million tonnes resulting in an annual export earning of US\$5 billion

Cassava market in trillions of naira

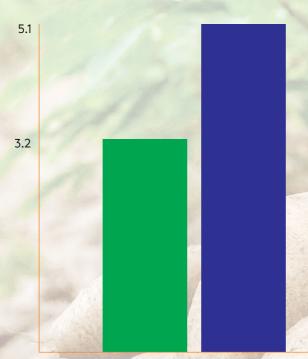

CUTIVE PLATINUN

This focuses on management of the entire process from cultivation to naira value in return. Here, the company is entitled to 40% of net income value.



CUTIVE DIAMOND

This is a focus on cultivation to handing over produce to the investor for onward commercial value returns. Here, the company is entitled to 25% of the net income value.



XECUTIVE GOLD

In this particular case, the investor chooses to manage the entire process from cultivation to commercial value in her own capacity. Here, the company is entitled to just 10% of the net income value.

The Rewards



According to a Nigerian Presidential Initiative of July 2002, the cropped area of cultivation of cassava was proposed to be increased to 5 million hectares by the end of 2010 with a projected annual yield of 150 million tonnes resulting in an annual export earning of US\$5 billion. You should be harvesting between 7 to 12 tons of cassava per acre depending on the variety, and agronomy practices adopted. The cost of cassava is a function of the market, harvesting periods and your location. The price of cassava depends on seasonality, regional production levels, and production cost. As of today November 19, 2024, the price per ton of cassava in Nigeria ranges from approximately NGN 150,000 to NGN 170,000.
